## Keynote Speakers

### Peter Mucha

Peter J. Mucha is a Bowman and Gordon Gray Distinguished Term Professor and the Chair of the Department of Mathematics at the University of North Carolina at Chapel Hill. After a childhood spent mostly in Minnesota, he majored in Engineering Physics at Cornell, followed by a Churchill Scholarship to study in the Cavendish Laboratory at Cambridge with an M.Phil. in Physics, and then an M.A. and Ph.D. in Applied and Computational Mathematics at Princeton. Following a postdoctoral instructorship in applied mathematics at MIT and a tenure-track assistant professorship in Mathematics at Georgia Tech, he moved to Chapel Hill to join the Department of Mathematics and the Institute for Advanced Materials, Nanoscience and Technology at UNC. His primary research efforts are currently in the area of networks, with work spanning collaborations in Biostatistics, Finance, Physics, Political Science, Psychology, Sociology, and Statistics.



## **Jerry Reiter**

Jerry Reiter is the Mrs. Alexander Hehmeyer Associate Professor of Statistical Science at Duke University. He received his Ph.D in statistics from Harvard University in 1999. His primary research interests include methods for handling missing data, for protecting confidentiality in public use files, and for the analysis of complex surveys. He is the PI of the Triangle Census Research Network, one of eight NSF-Census funded research nodes with missions of improving practice in the federal statistical system. He is an associate editor for the *Journal of the American Statistical Association*, *Survey Methodology*, the *Journal of Privacy and Confidentiality*, and the *Journal of Statistical Theory and Practice*. He is a Fellow of the American Statistical Association. He was awarded the 2007 Alumni Distinguished Undergraduate Teaching Award, given annually by Duke students to faculty for excellence in undergraduate teaching.
